## 1) The Chairman called the meeting to order at 9:05 a.m.

#### 2) Remarks from the Chair

Charlie Catholique, Vice-Chair, opened the meeting with a welcome to the invited guests and Board of Directors to the Environmental Monitoring Advisory Board Annual General Meeting, and called for a moment of silent reflection.

ED noted that Annual Report is not available for circulation as Board Members have not yet approved the text.

Agreed to postpone the Chair's remarks until the Chair arrived.

#### 3) Introductions and comments from the Parties

The Vice Chair asked participants to introduce themselves and invited any comments. Kate is Manager of the EA Group at ENR.

Monica is Environmental Assessment Analyst at ENR.

Alex is the Regulatory and Research Specialist of Department of Land & Environment at YKDFN Jennifer O'Neill is Senior Implementation Negotiator with Indigenous and Northern Affairs Canada Zabey Nevitt is Special Advisor to the Tlicho Government

GNWT - no comment.

Diavik – 2016 saw a refreshed EMAB from Diavik's perspective. EMAB engaged well with Diavik and seemed helpful to communities. EMAB should be commended for efficiency and effectiveness over the last 12 months.

YKDFN – EMAB has done a good job on a meager budget. YKDFN would like to see EMAB undertake more reviews, with greater detail, but that is hard to do with the current budget.

Diavik – asked where Parties stand on the initiative to amend the Environmental Agreement.

YKDFN – there had been discussion of restructuring EMAB, but this is no longer active.

Tlicho Government – Tlicho had a discussion with Diavik a few months ago and decided that EMAB will be as successful as the people that are appointed, the budget provided and the level of cooperation among members. Changing the structure of EMAB won't necessarily mean it will be more successful. Parties have the right to appoint whoever they want to the board; these could be science-based appointments, community-based appointments or other. Perhaps there is a way to create a more certain funding formula and this might require changes to the Environmental Agreement (EA). They would be happy to consider proposals from others.

YKDFN – relies heavily on EMAB's technical reviews.

Vice-Chair notes EMAB's site visit the previous day. He is happy to see what Diavik is planning with the sloping and smoothing of the NCRP.

## **Chair Remarks**

The last 12 months have been challenging, but EMAB is in a good place now to review environmental management plans and monitoring reports. EMAB is trying to provide advice to Party environmental managers, and NSMA is willing to accept recommendations from EMAB. Hope that Party environmental departments are re-engaging with staff and the board.

- "Cheat sheet" for coding

## 9) Environmental Agreement Amendment / Review

Kate Witherly updated the meeting on behalf of the GNWT.

- GNWT is amending all three Environmental Agreements (IEMA, SLEMA and EMAB) post devolution; they will deal with each EA separately
- There was some opposition originally, related to the role of INAC after the amendments
- GNWT is going to come up with a work plan and send to Parties and EMAB
- The amendment will reflect new roles of GNWT and INAC, with INAC playing a limited role
- GNWT and INAC are seeking input from Parties; all Parties must agree in order to change the EA.

Diavik asked if there will be any other changes to the EA and noted the GNWT said they would lead a review of the EA.

- The EA has never been reviewed
- Security sections are complicated

GNWT indicated that if Parties propose a review it will agree.

INAC noted that the Parties wanted INAC to continue to be involved. INAC and GNWT will work together to approach the other Parties with a proposal.

GNWT will facilitate an assessment of the EA as set out in para. 17.2 of the EA.

Kate will be away, so Monica Wendt will be the main contact for GNWT, including for any questions.

Noted that Erin Kelly is the new Deputy Minister for ENR.

Diavik recommended to review the EA.
