1) Call to Order

The Chair called the meeting to order at 9:05 a.m.

Moment of silence

Chair noted some important changes to EMAB in the last year: passing of Jack Kaniak, long-time KIA Board member and Vice-Chair; new Board members since last AGM – Kelly Fischer and Sean Erasmus; new Environmental Specialist Allison McCabe.

Chair also reviewed EMAB activities for the past year including: Natural Drainages Water Licence Amendment, Diavik Final Closure Plan review; 2021 TK Fish Camp; approval of 2023-25 budget and formation of TK Working Group by Parties.

2) Adoption of Agenda

3) Conflict of Interest

4) Chair's Remarks

Chair asked if there were any comments from the Parties.

5) Comments from the Parties

- Marc Whitford said things are going well with EMAB and it will be important to stay involved in closure at the mine
- Gord Macdonald said Diavik continues to feel that the main value of EMAB is its technical reviews.
- Violet Camsell-Blondin noted the difficulty with some Traditional Knowledge activities and concerns of Elders
 about the long-term effects of Diavik on Lac de Gras. It is important to have TK input. She appreciates Diavik's
 help in gathering TK and wants to maintain a good relationship with the mine.
- Doris Enzoe suggested EMAB convene a meeting of Elders and youth now that mine closure is approaching.
 She wants to see how fish in Lac de Gras are doing, following the 2021 TK Fish Camp. She would like to see the results of fish sampling shared with communities.

6) Approval of Minutes

Review of October 5, 2022 Annual General Meeting minutes.

Noted that LKDFN did not sign the Devolution Agreement. They plan to invite the Minister in charge of devolution to explain devolution to the community.

7) March 31, 2023 - Audited Financial Statements

Ethan Oatman from EPR presented the audited financial statements

- Clean audit; this is the best assessment an auditor can give
- Underexpended in 2022-23
- Contribution repayable of \$61,777 to Diavik. Noted that this should be added to the income statement.
- Some differences from previous years due to relaxation of COVID travel restrictions

Q: will inclusion of \$61,777 change the bottom line?

A: no

 Had planned to send out a final letter stating that since there wasn't consensus agreement among the Parties GNWT would not pursue amendments to the EA at this time. Will hold off, pending request for a community meeting with LKDFN.



• Note that the upcoming election will affect who the Minister is; suggest holding off request until cabinet is appointed.
