## 1EA Implementation Review

Noted – Email from Erik Madsen/Diavik. ("Regarding the SENES report and comments from the Parties I do not agree with the Executive Directors recommendation that the report be approved/released now and that we instead consider the comments from the Parties at a later date and separately. The purpose of the SENES report was to conduct an independent review including input from the Parties. It was indentified that there wasn't a lot of Party input – so we requested again. Now that we have it we should get SENES to use it. I recommend that we provided the comments directly to SENES in writing (ie not a summary of the comments but the actual comments themselves) and that we ask SENES to a) append the comments to their report b) consider the comments c) make any changes to the report they believe to be justified based on the comments submitted. Remember this will still be a SENES Report. Once the report is finalized it will then be up to EMAB to consider how to address the conclusions and recommendations contained in the Report.")

General agreement. Executive Director will call SENES re: cost.

There is one missing written comment. ED did talk with the Lutselk'e SAO, who indicated something would be in by today.

ACTION: ED will proceed with SENES re: update the report on the EA review, unless the cost is outrageous.

Q: EMAB has written letters of support in the past. What was the process?

A: There isn't a policy.

ACTION: ED will request the proposal, distribute it, and the Board will proceed by email motion.

Q: Does EMAB want to respond to the Minister's letter.

A: Yes.

ACTION: Write a letter to the Minister acknowledging the response, not that EMAB is looking forward to seeing a plan, and we will attend the proposed March 15 meeting.
